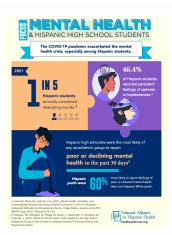

New Bilingual Infographics on the Mental Health Crisis in Hispanic Communities

New Toolkit on Vaping & E-Cigarettes for Working





To mark the start of National Minority Mental Health Month (July 2022), the National Alliance for Hispanic Health released a series of infographics to highlight the mental health crisis that exists among Hispanic high school students as well as for Hispanic adults.

According to findings released in the infographics, nearly 1 in 5 Hispanic high school students(19.7%) seriously considered suicide and nearly half (46.6%) reported persistent feelings of sadness or hopelessness in 2021. The COVID-19 pandemic has transformed a decade-long trend of students' declining mental health into a national emergency.

The data for adults is also concerning. The data from June 2020 revealed that Hispanic adults were the community most likely to repport at least one adverse mental health condition, including anxiety disorder or depressive disorder. Moreover, Hispanics were the group most likely to have considered suicide. Furthermore, treatment rates for Hispanic individuals living with a mental illness are alarmingly low. In 2020, only about a third of Hispanic adults with a mental illness received treatment, compared to nearly half of all non-Hispanic individuals.

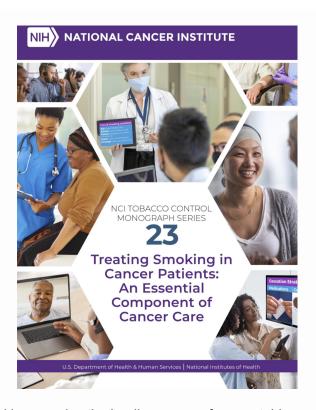
New Monograph from the NCI for Treating Smoking in Cancer Patients

Smoking remains the leading cause of preventable disease and premature death, accounting for 30% of all cancer deaths in the United States. Because continued smoking during cancer treatment adversely influences the effectiveness of therapy, as well as recovery, it is vital that clinicians—as well as patients with cancer—recognize that it is not too late to quit smoking at any stage of the cancer care continuum, and that there are clear benefits to doing so.

This new NCI Tobacco Control monograph, **Treating Smoking in Cancer Patients: An Essential Component of Cancer Care**, synthesizes the evidence that smoking
cessation treatment increases the quit rate for patients
who smoke, identifies evidence-based interventions that
have the potential to enhance the delivery of smoking
cessation treatment in the cancer care setting, discusses
special considerations for medically underserved and
vulnerable populations who smoke, and identifies
important research gaps related to these topics.

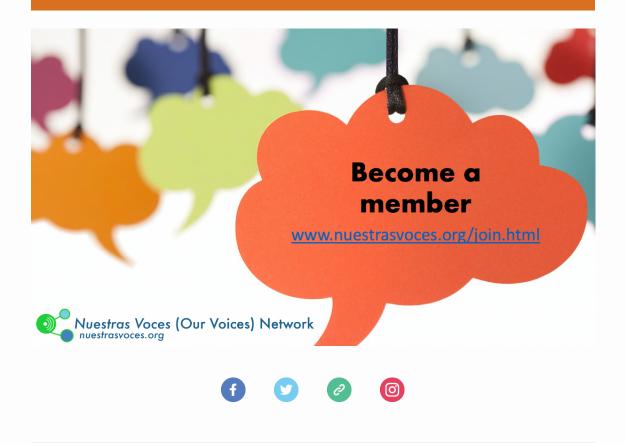
Opportunities for Little "p" Policy Change in Increasing HPV Vaccine Uptake
